
Re: Motion for Continuance of Area 3 Cost-Replacement Hearing

On behalf of the Area 3 Milk Dealers, I write to request a continuance of the Area 3 cost replacement hearing scheduled for February 2, 2022 and an adjustment of the current rebuttal and surrebuttal deadlines for the Area 3 hearing. Our accountants have identified some data that requires an added level of review before they can confidently present to the Board. The Board Staff supports a continuance to March 2, 2022 when the remaining cost replacement hearings are scheduled. Therefore, the Area 3 Milk Dealers seek a continuance of the Area 3 cost replacement hearing to March 2, 2022 as well as an adjustment to the rebuttal and surrebuttal filing deadlines to reflect the new hearing date.


