**DISCUSSION:** Secretary Moyer presented that September Farm, LLC has submitted an application for a subdealer license, for 2017-2018. Applicant will purchase bulk milk from a cooperative. Applicant will manufacture cheese and yogurt products for resale to stores and distributors in Area 1. A bond has been provided. Appropriate staff has reviewed the application to ensure that all forms have been received and are in order, and that the applicant has met the requirements of the Milk Marketing Law. A Provisional license was granted on March 30, 2018. With Board approval of this application, a subdealer license will be issued. He stated the license fee had been sent to the incorrect office and we are awaiting license fee payment.

Moved to approve a subdealer license to September Farm, LLC contingent upon receipt of the license fee. **Seconded by Member Van Blarcom.**
