February 4, 2019 1:00 P.M. – Room 309 – Ag Building Harrisburg, PA

## 1. CALL OF MEETING TO ORDER/ROLL CALL:

**Chairman Robert Barley** called the regular Sunshine Meeting of the Pennsylvania Milk Marketing Board to order at 1:00 P.M. in Room 309 of the Agriculture Building in Harrisburg, PA. Chairman Barley opened the meeting with the Pledge of Allegiance followed by a moment of reflection.

### 3. PUBLIC INPUT (PERTAINING TO GENERAL ISSUES:

**DISCUSSION:** Mr. Turner from Turner Dairy informed the Board of the passing of Edward Schneider, he was a competitor who helped build the dairy industry in western PA.

#### 4.. OLD BUSINESS:

Chairman Barley commented on the amendment to 7 Pa Code 143.31 referencing the 90-day Notice. The Board is taking comments through Friday, February 8<sup>th</sup>, and will take comments into consideration in preparing the proposed regulations. All parties involved will be informed.

Attorney Yovienne stated that the due date for comments was noted prior as Monday, February 4<sup>th</sup>. Chief Counsel Eberly confirmed that all comments are due through Friday, February 8<sup>th</sup>, instead.

## 5. NEW BUSINESS:

1. Request date/time change for the March Sunshine meeting.

**PRESENTED by**: Chairman Barley

**<u>DISCUSSION</u>**: Chairman Barley proposed changing the March meeting from Wednesday, March 6, to Friday, March 8<sup>th</sup>, at 12:30 PM and immediately followed by the Over-Order Premium hearing.

**MOTION by**: Member Van Blarcom

Moved to accept the change to the March Sunshine meeting as stated. **Seconded by Consumer Member Hardbarger. Motion carried without dissent.**

**2.** Amendment to 7 Pa Code chapter 150 Milk Marketing Fees.

**PRESENTED by:** Secretary Moyer

**DISCUSSION:** Secretary Moyer stated that the last fee increase was in January 2004, and with the loss of controlled sales the Board is looking at all the fees that generate funds for the agency. Steve Zalman has developed a template for the analysis of the revenue structure.

**MOTION by**: Consumer Member Hardbarger

Moved that the Board review 7 Pa Code chapter 150 Milk Marketing Fees, for the purpose of assessing our revenue structure and proposing amendments. **Seconded by Member Van Blarcom. Motion carried without dissent.**

3. Petition for Transparency and Accountability with the PMMB Over-Order Premium.

**PRESENTED by:** Chairman Barley

**DISCUSSION**: Chairman Barley stated that there was a petition submitted to the Board by State Representative John Lawrence, for Transparency and Accountability with the Over-Order Premium. This was presented at the Lebanon Listening Session and the Board is taking it under consideration.

Attorney Beshore commented that PADC is not taking any position on the matter but noted that the issue of transparency it is not always a simple or direct one. Within any organization there are many ways it can be represented. There are different dynamics within the different parts of the state and how the

information is communicated. There is statutory language giving coops the prerogative to allocate funds amongst its members, which is not be constrained.

Attorney Yovienne had no comment on the matter at this time since it was something being looked at for the first time.

MOTION by: Consumer Member Hardbarger

Moved that we investigate the statutory issues surrounding this Petition for Transparency and Accountability. **Seconded by Member Van Blarcom.** 

Consumer Member Hardbarger amended her motion to state, that the Board will investigate the statutory and regulatory issues and potential changes. **Seconded by Member Van Blarcom.** 

Consumer Member Hardbarger stated further that though her tenure on the Board has been short, her effort is to always be as fair and open in listening to all sides of every issue and weighing those within her best judgment of what is presented, and what is law and our regulations. And she commented that this item warrants being looked at within that framework.

**4.** Pennsylvania-New York weigher/sampler reciprocity agreement.

**DISCUSSION**: Chairman Barley presented the reciprocity agreement in which Pennsylvania and New York will accept each other's weigher/sampler certifications. One does not have to be certified by both states.

Moved to accept the Pennsylvania-New York reciprocity agreement. **Seconded by Consumer Member Hardbarger. Motion carried without dissent.**

Chief Counsel Eberly asked the Board to go back to New Business items #2) Amendment to 7 Pa Code Chapter 150 Milk Marketing Fees, and #3) Petition for Transparency and Accountability with the PMMB Over-Order Premium, and delegate to Mr. Moyer to follow through on those items.

Chairman Barley asked for a motion to authorize Mr. Moyer to proceed and follow through with the New business items #2 and # 3 as stated and approved.

He further stated that they also met today with someone from India, there are some similarities with the province or state where he lived in his home country of India. There is not enough production to meet their demand, he was looking to explore ways to export milk to India.

1. Enhanced Community Organics Cooperative D/B/A Lancaster ECO

**PRESENTED by**: Attorney Saylor

DISCUSSION: Attorney Saylor presented that Enhanced Community Organics Cooperative D/B/A as Lancaster ECO, has submitted an application for a dealer license for 2018-2019. Applicant is a cooperative arranging to have its own milk processed into drinkable yogurt. Applicant has provided a sworn certification from Applicant and the processor that the charge for processing is not less than the processor's cost, that the applicant is providing only its own milk for processing, that the milk is not being sold to the processor, that the processor provides the finished product to Applicant, and that the processor and Applicant are not buying or selling or exchanging milk or any controlled products in any transactions with each other (or with any related entity). Applicant intends to sell drinkable yogurt to stores in Areas, 1, 2, 3, and 4. Appropriate staff has reviewed the application to ensure that all forms have been received and are in order, and that the applicant has met the requirements of the Milk Marketing Law. With Board approval of this application, a dealer license will be issued.
