- Violation: This Defendant, a licensed milk dealer, failed to file its Milk Dealer's Monthly Report (PMMB-62) for October 2022 on or before November 25, 2022; November 2022 on or before December 26, 2022; and December 2022 on or before January 25, 2023, in violation of section 702 of the Milk Marketing Law (Law), Act of April 28, 1937, P.L. 417, <u>as amended</u> (31 P.S. §700j-702) and section 147.10 of the Regulations of the Pennsylvania Milk Marketing Board (7 Pa. Code § 147.10).
- Disposition: Defendant executed a Consent Order which acknowledged this violation and consented to the settlement of the Citation with the Board in the amount of \$200.
- 2. <u>PMMB v. SUPERIOR DAIRY INC</u> Legal Docket No. CA-23-004
 - Violation: This Defendant, a licensed milk dealer, failed to file its Milk Dealer's Monthly Report (PMMB-62) for February 2023 on or before March 27, 2023, in violation of section 702 of the Milk Marketing Law (Law), Act of April 28, 1937, P.L. 417, <u>as amended</u> (31 P.S. §700j-702) and section 147.10 of the Regulations of the Pennsylvania Milk Marketing Board (7 Pa. Code § 147.10).
 - Disposition: Defendant executed a Consent Order which acknowledged this violation and consented to the settlement of the Citation with the Board in the amount of \$500.
- 3. <u>PMMB v. PEQUEA VALLEY FARM LLC</u> Legal Docket No. CA-23-003
 - Violation: This Defendant, a licensed milk dealer, failed to make timely payments to producers when due, in violation of Section 626.5 of the Milk Producers' Security Act (31 P.S. § 626.5) and of Milk Marketing Board Regulation 7 Pa. Code Section 143.12(a).
 - Disposition: Defendant executed a Consent Order which acknowledged this violation and consented to the settlement of the Citation with the Board in the amount of \$1000.
